Either party may terminate this Agreement upon written notice to the other party in the event of a material breach of any provision of this Agreement by the other party, which breach remains uncured for a period of 30 days following written notice thereof.

## 10. Governing Law and Jurisdiction

This Agreement shall be governed by and construed in accordance with the laws of the State of New York, without regard to its conflict of laws provisions. Any disputes arising

out of or in connection with this Agreement shall be resolved exclusively by the state and federal courts located in Westchester New York.

#### 11. Entire Agreement

This Agreement constitutes the entire agreement between the parties with respect to the subject matter hereof and supersedes all prior and contemporaneous agreements and understandings, whether written or oral, relating to such subject matter.
